QuicSend online social seller contract

The role — **Perfect for:** working from home, business majors, travellers/backpackers, sales executives, students, job hunters and everyone in between looking to work in a virtual office space!

Welcome to QuicSend. This is currently an entry level paid role with potential of full time work in the coming year. There is also an option for scheduling your work around casual hours while receiving a full starting wage. As the role is primarily online you will need to adhere to a certain level of dedication by paying a membership fee of \$14.50 per month.

You will be authorised to use all branding, virtual business card, marketing and logo as provided by the company president. All rights and legalities surrounding branding, marketing, virtual business cards and logo are protected under trademark law. You will register yourself as an independent contractor and pay all due taxes under online social seller for QuicSend. This is a high tech company and so we expect all relevant responsibilities to be arranged under part-time self-employment upon sign up.

We will set up a two hour training session for you to go over your job description, KPI's, selling strategies, promotional guidelines and a demo of how the process works. We also have a setup fee of \$99 with your first month membership fee included and so a combined total of \$113 is expected for starting at QuicSend.

As the role is part time between 16-20 hours per week there is potential of earning over \$200+ per month, and so we expect a strong work ethic and time dedicated to your online social seller position.

If there is failure to do so or your performance drops tremendously within 6 months you can expect a review of your role working for QuicSend or even a termination of your contract based on circumstances.

You will be responsible for promoting businesses online and maintaining a high level of professionalism with your co-workers and our clients. At no point are you expected to share private business or personal information pertaining to staff or our clients with any organization or group either online or in person other than what is specified in the training guidelines of our work.

The failure to do so may result in a hefty penalty and/or a termination of your contract. We have started an organization based on helping to promote small businesses online while providing work available from home, and we would like to keep this process fun, respectable, results-driven and reliable. We would rather see you prosper than to see you in despair!

As we will be mostly working online through distance we will expect full communication at all times.

The two platforms we will be using for our clients are Facebook and LinkedIn. You will receive a 20% starting wage of \$22.60 deducted from your setup fee.

This will be automatically paid into your account monthly as well as your earnings from your total sales so that your returns become higher than what you pay for your time at QuicSend each month! Please save 10-20% of all earnings for tax as it is non-inclusive. **We will take** no responsibility for unpaid taxes and may even charge a hefty penalty for damages.

All training and follow up meetings will be via messenger video calls for efficiency. There is a two hour training session upon sign up and follow up meetings to help keep you motivated.

If you have any questions or concerns feel free to contact us anytime between business hours of 9am-5pm NZD time.

Leave and holidays: We do not have a set rule when it comes to taking time off. We expect regular breaks and time to cool off as needed as work will be highly flexible and tech-based.

As stated above, if your performance goes awry in the span of 6 months you will be liable for a review of your role at QuicSend or even a termination letter depending on reasons for decline.

If you are unable to work due to illness, pregnancy or any other conflicting circumstance please let us know in ample time so we can arrange cover or find someone suitable to take over your role for the time being. You will be paid for any outstanding sales before taking extended leave.

Quality control

We have some basic rules and regulations surrounding selling the home-based service to your family and friends to help with your sales and KPI targets each month.

It is also worth noting that every member who signs up to work with QuicSend will be paid the same amount of money from our sales structure to keep the process fair, and to avoid recruitment ranks as best as we can.

- 1. Please do not begin to train friends or family unless they have signed up or are waiting on confirmation of their sign up through your referrals! We will train buyers who you have referred outside of your social circle or members who are not directly your friends and/or family. Please keep a record of all sales/purchases and names of patrons you have sold to for safekeeping and accurate pay. We will also check this on our end to help confirm and keep track of all sales.
- 2. You will need to adhere to our company culture of only referring to buyers who have sales experience and/or knowledge, and an understanding of ecommerce. All buyers must be professional and serious with a strong work ethic and a consistent willingness to show up every day. An outstanding sales record with any company is also a bonus but not necessary.

- 3. We have two programs listed on our site for small business use and for home-based sellers. You will begin your OSS (online social seller) journey by focusing solely on selling our home-based programs to at least 60 buyers per month ideally. If you are able to keep to a 20-25 result this is also acceptable within our sales structure.
- 4. We do encourage you to strive higher so that you are able to upgrade to building platforms and target markets online for our clients who sign up for the smart online business seller program. We will also train you on this process once the time comes.
- 5. As an online social seller you will be primarily selling our home-based program while also promoting business links to help small businesses get new leads, increase web traffic and promote their products/services daily. **Do not spam/cold message or use pushy sales tactics when promoting as this will result in immediate termination of your contract**.
- 6. We are a professional online promotional service with quality growth hack methods in place! You will only be required to use the marketing process we implement as instructed in your training.
- 7. Please send links for 20 mins within your inbox every morning to provide optimum link delivery from QuicSend. This demo will be provided in your training upon sign up.

Sales structure - How our virtual tip jar works!

Once you have reached 150 sales with us and have signed up at least 20 businesses we will train you on how to work for our 'smart online business seller' developing algorithms and online advertising/target market platforms for our small business clients.

As a general rule you are more than entitled to sell our smart online business seller program alongside the home-based program but we only recommend that you do so if you can handle the workload or would like an extra bonus each month along with your total number of OSS home-based sales.
